FINAL JUDGMENT ON LIQUIDATED DAMAGES AGAINST DEFENDANT FAIRFAX STUDIOS, INC.

THIS CAUSE having come for hearing before the Court on May 23, 2022, on Plaintiff Rolling Loud, LLC's ("Rolling Loud") Motion for Entry of Final Judgment on Liquidated Damages Against Defendant Fairfax Studios, Inc., a/k/a Fairfax Studios LLC ("Fairfax Studios") (the "Motion"), and the Court having carefully reviewed the Motion and the record, including the March 30, 2022, Order entering a default as to liability against Defendant Fairfax Studios, and being otherwise fully advised in the premises, it is hereby **ORDERED AND ADJUDGED** as follows:

- 1. The Motion is **GRANTED**.
- 2. The Court finds that Plaintiff Rolling Loud's claims against Defendant Fairfax Studios for unjust enrichment (Count III) and conversion (Count IV) are for a liquidated sum certain.
- 3. In the alternative, the Court finds that Plaintiff Rolling Loud is entitled to summary judgment in the amount of damages proven on its claims against Defendant Fairfax Studios for unjust enrichment (Count III) and conversion (Count IV). See KB Home Ft. Myers Ltd. Liab. Co. v.

- 4. Accordingly, Final Judgment is hereby entered in favor of Plaintiff Rolling Loud, LLC and against Defendant Fairfax Studios, Inc., a/k/a Fairfax Studios LLC, on Counts III (unjust enrichment) and IV (conversion) of the Complaint, for the damages amount of \$800,000, which shall bear interest at the rate of 4.25% a year, [1] for which let execution issue.
- 5. The address of Judgment Debtor Fairfax Studios, Inc., a/k/a Fairfax Studios LLC is 251 Little Falls Drive Wilmington, Delaware 19808.

- 8. Pursuant to Florida Rule of Civil Procedure 1.560(b), within forty-five (45) days of the date of this Order, Fairfax Studios, Inc., a/k/a Fairfax Studios LLC shall provide to Rolling Loud, LLC a completed and sworn Fact Information Sheet (Form 1.977 of Florida Rules of Civil Procedure). The Fact Information Sheet is attached to this Final Judgment.
- 9. This Court retains jurisdiction to enforce the terms of this Final Judgment, including entering a separate judgment amount to account for any costs. This Court also retains jurisdiction over the remaining claims in this action over which no judgment has been entered to date.
- 10. Rolling Loud, LLC shall have the right to immediately initiate proceedings supplementary to and in aid of execution of this Final Judgment and to request such other relief deemed proper.
